Rules for racing class:

All mowers must have working kill switch, have lawnmower transmission and engine Except for open class.

- * Single cylinder – any single cylinder lawnmower engine, does not matter what size or what kind of mower
- * Twin cylinder – any twin cylinder lawnmower engine up to 22hp
- * Open class– any engine, any lawnmower engine, and all engines over 22hp
- * Russell County Cup - will be the 1st, 2nd, 3rd place finishers in the races listed above

Kids Class

- Heat 1- (kids class)- ages 11-15, All mower types and permitted, Preferred a single flathead

Adult Classes

- Heat 2 (STOCK SINGLE)-single cylinder engines (all) (intake & exhaust mods are permitted) Gear ratios are open, no live axles, no engine work.
- HEAT 3- (MOD SINGLE) - All single cylinder engines (OHV's & Flatheads). Frame/Steering/Engine can be modified. Live axles, all modified engines.
- HEAT 4-(STOCK TWIN) - twin cylinder engines (OHV's & Flatheads). All engines to be less than 22HP, no live axles, no modified engines.
- HEAT 5-(MOD TWIN) - twin cylinder engines (OHV's & Flatheads). Frame/Steering/Engine can be modified. All engines to be less than 22HP, live axles, and modified engines.
- HEAT 6-(Open) - Unlimited Horsepower and modifications, any engine size.

Russell County Fairgrounds or anyone associated with this Event is not liable for injury, loss of property, or damages resulting from participation in this event. If under the age 18, must be signed by an adult. I have read the rules and accept the Decision of the judges as Final and elect to use the grounds or track in its present Condition.
